Mary shared the following:

- 10<sup>th</sup> Anniversary of SCLH Lost Pets Program
- Received reports of 8 Dogs, 5 Cats, and 1Turtle. NO LOSES! (Jan 1<sup>st</sup> May 10<sup>th</sup> 2024
- Process followed when a pet is found/reported: Pet is scan for a chip (she calls company if it has
  one), takes picture of pet, posts/ call village coordinators of surrounding villages. Cannot do the
  entire community. Chip company will notify owner, will only give me the name and age of the pet.
- Process followed when a pet is reported LOST: Requests picture of pet, collects information, posts and emails village coordinators. Checks on pet status next day call animal control to see if they have it and provides village coordinators with updates.

  - so far this year 300 people have attended/requested information on the mailbox captains.
- O NATIONAL NIGHT OUT COORDINATOR (S)—SUZANNE ROSEVOLD AND STEPH GUILLORY
  - NNO kickoff August 17<sup>th</sup> and NNO event October 1<sup>st</sup>.
- O ALERTS PROGRAM COORDINATOR ALERTS TO DATE MARY CRANSTON
  - Since January 1, 2024, NW sent a total of 16 alerts and FYI's
- O BORIS THE BURGLAR STREET SIGNS COORDINATOR ED ZYCHOWSKI
  - 10 signs replace so far this year.
