Registration Program

- Registration is voluntary.
- No cost associated with registration.
- · Information is kept confidential.
- Only residents have access to their camera recordings.
- Police only use the registrations to locate cameras in a neighborhood where a crime is reported. No one can access to your camera or your recordings.

Lockbox

Residents often install lock boxes on their property that contain a key to their home. The
key is for public safety use in the event of an emergency. Having a key available for
public safety emergency use expedites access into the residence will minimize damage
to the property.

Information pertaining to your lockbox, contents, and combination are private. The Lincoln Police Department will not share or disclose this information unless required by law.

Entry into a residence by public safety personnel shall only occur when lawful circumstances exist (e.g. emergency or exigent circumstances). Registering with this program does not imply consent for entry.

SCLH Security Camera Requirements

- To place a Security Camera on the front of your house you must do the following:
 - Complete an ARC Application <u>Checklist 6</u> found at sclhresidents.org
 Library/Forms/Community Standards/ARC Forms/ARC Forms and Applications.
 - Obtain a City of Lincoln permit, if required. ARC will tell you when your application is approved.
 - Register your camera at the City of Lincoln Camera Registration (Optional)

SCLH Camera-Surveillance Guidelines

- The video coverage of all cameras installed could extend into the public sidewalk and street but cannot focus on any neighboring properties.
- Doorbells with cameras do not require ARC approval but must follow the same video requirements.
- A maximum of eight, (8), video cameras may be installed on the property.
- Cameras operated with solar are permitted, however, solar panel must be installed in the least visible location from the street and cannot attach to architectural features.
- Motion activated light/camera assemblies can be used to replace existing exterior lights found on garages or sides of house. Light cannot focus on or interfere with neighboring properties or street.

SCLH Camera-Surveillance Guidelines

- A photo brochure of style, color and dimensions of camera and/or carriage style fixture must be submitted with application.
- Wiring must be concealed or installed in a conduit.
- Mounting hardware and conduit must be painted to match the color of the adjacent surface.
- Cameras cannot be attached to the house's architectural features.

Video Security Cameras

- Home security cameras are DIY devices
- Self monitored
- No security company connections
- Relatively affordable





Video Doorbells

 These doorbells are motion activated and will allow you to see the person that is at your door. It is capable of recording a video of the subject and you are able to have a two-way conversation with the person at your door using your cell phone. Ring and Google Nest are popular brands and they can be purchased through Amazon or other on-line or home improvements stores. ARC approval is not required for video doorbells.

Cost: Starting at \$100.00

Video Doorbells

- **Pros:** They use doorbell wiring for power or some are battery powered. You can answer your doorbell even when you're not home.
- **Cons:** They won't work with an existing wireless doorbell chime. Their connection to your WiFi may be affected by being outside the thick walls of your home. Cloud storage fees can be high. Some smart features require paying a monthly fee.



SECURITY CAMERAS


These cameras can record the area around the outside and inside of your home and will allow you to see the live views from your smart phone or laptop. They are capable of HD quality and have great lowlight performance which makes for crystal clear video. These camera systems provide many options from a one camera system to having multiple cameras covering the perimeter of your home. These security cameras can be purchased through Amazon or other on-line or home improvements stores, or through companies that will provide complete installation of the systems. Please refer to Association's Design Guidelines 21 on use and placement of cameras. ARC approval is required.

Cost: Starting at approximately \$180.00 to many thousands of dollars

Video Cameras

- **Pros:** They can be placed just about anywhere inside your home. Weatherproof models can be placed outdoors. You can check on your home and receive smartphone alerts from anywhere with cell service or WiFi.
- Cons: Cloud storage fees. Some smart features require paying a monthly fee. Must have a good WiFi signal where the camera is mounted.

How to Choose a Home Security Camera



Choose Your Camera Type

- Where you want to place it?
 - Inside your home there are many home security camera options.
 - Outside your home wireless, a video doorbell or a wired.
- Monitoring a front door consider a video doorbell powered through doorbell wiring or battery power.
- Monitoring another area of your property use a wireless security camera.
 - If you install a camera outside of your home, have a good WiFi signal at that location.

Pick Your Power Source

- Battery-powered wireless security cameras and video doorbells offer the most flexibility in terms of placement in and around your home.
- Depending on the camera and how heavily it's used, you'll need to recharge it anywhere from weekly to once every few months to once or twice a year, some now have a two year battery.
- Hardwired cameras and doorbells neatly sidestep the recharging problem but may limit your placement options, unless you're willing to run an extension cord or hire an electrician.
- Keep in mind that the power source you use could limit the number of models you can choose from. This is especially true of video doorbells because there aren't many battery-powered models on the market.

Compare Cloud Storage Plans

- Check how much free cloud storage the camera comes with and how much additional storage costs.
- Most manufacturers opt for cloud storage where the footage is remotely stored on a server – instead of memory cards because the video files are large. Without cloud storage, if you miss an alert for a potential intruder, you'll have no idea whether someone tried to break in.
- Many of these cameras also won't let you download clips to send to authorities unless you
 pay up. The amount of free online storage and cost of storage plans can vary drastically by
 manufacturer.
 - Examples: <u>check with manufacturers</u>
 - Netgear's Arlo cameras
 - Ring video doorbells offer no free
 - Nest, which offers only continuous video storage
 - Zmodo gives you both clips and continuous video in its storage plans.

Consider Your Privacy

- Cameras provide peace of mind, it's worth remembering that to do that they
 provide a view into your home and connect to the internet. If you can watch
 your home from your phone, it may be possible for someone else to take a
 peek, too.
- Set up unique username and difficult-to-guess password when setting up your system.
- These security concerns don't mean you shouldn't buy a home security camera, but if privacy is something you're worried about, you may want to keep these devices out of bedrooms.
